Hamm Quarry, Inc. of Perry, Kansas, which contract is an agreement for the purchase of 30,000 tons of state tested AB-3 at \$2.05 per ton for a total of \$61,500. Payment for the above material is to be made upon completion of crushing. The material is to be stockpiled at the Harrell Quarry location which is in Section 35, Township 13 South, Range 18 East in Douglas County. It is intended that the funds to pay for this purchase of rock be obligated from 1977 Road and Bridge funds. After discussion on the contract and its recommendation by Dean Sanderson, director of public works, it was moved by Mr. Neis that the recommendation for approval be accepted, seconded by Mrs. Bradley, and carried unanimously.

The Board received a recommendation from Roger Hedrick, director of planning,

At the advertised hour of 2:00 p.m., the Board accepted bids for bridge and grading contract for Project No. 77-4 on Douglas County Bridge No. 11.00N-21.15E. Seven bids were received for bridge only. No bids were received for grading items and as a result it was recommended by Bob Thorn, a representative of Finney & Turnipseed, and Dean Sanderson, director of public works, that the bids not be disclosed but be resealed and returned to the bidders inasmuch as no contract could be awarded since there would be no grading available on the project. It was recommended that this Project No. 77-4 be rebid at a later time in consolidation with additional bridges in the area which hopefully will prove to offer a more palatable grading contract. After review of this recommendation it was moved by Mrs. Bradley that it be accepted that the bid documents be so returned and that this project be set for rebidding at a later time, seconded by Mr. Neis, and carried unanimously.

The Board met with Mr. Duane Evans, a representative of the drug abuse council, who presented for the Board's consideration a revision of an application to SRS for a grant to provide funding for an Affective Theraputic Treatment Project. The period of funding would be 1 January 1978 and end 31 December 1978. The total cost of the project would be \$15,822. The contribution would be provided by Douglas County in the amount of \$6,872, with an in-kind contribution of \$950, with \$7,500 requested by SRS. After review of this grant application it was moved by Mr. Neis that it be approved and forwarded to SRS for their review and that this Board schedule a meeting with members of the drug abuse council to discuss this grant application and its effect as well as the future of their organization in terms of the previously submitted goals statement and the results of recent contacts with the Douglas County Citizens Committee on Alcoholism to determine together the future thrust of the drug abuse council. This motion was seconded by Mrs. Bradley and carried unanimously.
