Ms. Smith recommends to the Board that Sandra Stepan who is presently classified as a geriatrics aide at an hourly rate of \$2.50 should be reclassified as coordinating aide with an increase of \$0.05 per hour to \$2.55 per hour for this change in classification and responsibility. After discussion it was moved by Mr. Neis that this arrangement be approved, seconded by Mrs. Bradley, and carried unanimously. This increase is to be effective December 3, 1977.

Ms. Smith recommended to the Board an increase based on six-month merit review for Mary L. Johnson, nurses aide. The increase recommended is \$0.13 per hour which will bring her hourly rate to \$2.48 effective 3 December 1977. Contract to remodel
room for Margaret
D. Moore. Patient
will pay for work

Ms. Smith presented to the Board for its consideration a contract document between Grace M. Heider and the Board of Commissioners of Douglas County, Kansas. Lengthy prior discussion has been held on the formation of this contract and it provides as follows: That Margaret D. Moore is a sister of Mrs. Heider and is eligible to move to Valleyview Care Home but requires a private room with adjoining bath because of her inability to see and to hear; that Douglas County does operate and maintain a nursing home facility known as Valleyview Care Home, which facility can, by minor remodeling, provide a room with adjoining bath for the patient and the estimated cost for this remodeling is \$3,000. It is agreed by this document by Mrs. Heider to provide funds not to exceed \$3,000 for the cost of making the improvements suggested and in consideration for these funds Douglas County agrees to contract for improvements and to have them completed no later than 1 March 1978. It is understood by this agreement that upon completion of the improvements and payment by Mrs. Heider that the facility will be made available to the patient Margaret D. Moore on the following terms: That Margaret D. Moore will have the use of said facility except in the event of an emergency-epidemic where all isolation facilities in the community are in use, in which case the quarters used by Margaret D. Moore could be taken on a temporary basis as an isolation area or, in the case she needs skilled nursing care elsewhere; that payment for patient Margaret D. Moore will be made for regular room charges as a private patient or as a Medicaid patient if qualified. After a complete review of the contract document by this Board and by County Counselor Dan Young it was moved by Mrs. Bradley that this contract be approved, seconded by Mr. Neis, and carried unanimously. A copy of this contract will remain on file in the commission office.

Mr. Sanderson then presented to the Board for its consideration Resolution No. 77-33 which is a resolution placing certain Army Corps of Engineers constructed roadways located in the Clinton Reservoir area in the Douglas County and Kanawaka Township Road Mileages. Pursuant to K.S.A. 68-151b, the Board of County Commissioners entered into an agreement with the Department of the Army Corps of Engineers to relocate, lay out, and/or alter certain roadways located in the Clinton Reservoir area and pursuant to a contract with the Army Corps of Engineers No. DACW41-73-C-0067, Relocation Roads Nos. 1, 2, and 5 have been constructed by the Army Corps of Engineers contractor in accord-
