Loran Anderson, lieutenant, from the rate of \$1171 per month effective 1 January 1978, specially adjusted to \$1225 per month effective 1 January 1978. Mr. Anderson shall show 12 years of service with Douglas County.

James Flory, lieutenant, from the rate of \$1171 per month effective 1 January 1978, specially adjusted to \$1200 per month effective 1 January 1978. Mr. Flory henceforward is to be shown in the 10 to 15 year bracket effective as of 1 January 1978. His next eligibility for merit review is to be January 1983.

Mike Suitt, deputy, henceforward to be shown in the 10 to 15 year bracket as of 1 January 1978 being given credit for 11 years experience with Douglas County. His next merit review eligibility will be 1 January 1982.

Robert Van Hoesen, deputy, from the rate of \$1067 effective 1 January 1978, specially adjusted to the rate of \$1078 effective 1 January 1978 based upon his additionally responsibilities as a shift supervisor.

Andrew Armbrister, deputy, from the rate of \$1021 effective 1 January 1978, specially adjusted to \$1038 per month effective 1 January 1978 based on additionally responsibilities as a shift supervisor.

Floyed Baker, deputy, from the rate of \$1096 per month effective 1 January 1978, specially adjusted to the rate of \$1130 per month effective 1 January 1978 based upon administrative duties as process server supervisor.

Marilyn Steele, deputy, from the rate of \$1101 per month effective 1 January 1978, specially adjusted to \$1130 per month effective 1 January 1978 in compensation for being supervisor of warrants.

Jim Baldwin, deputy, from the rate of \$1000 per month effective 1 January 1978, specially adjusted to \$1025 per month effective 1 January 1978. Henceforward Mr. Baldwin will be shown in the 5 to 10 year bracket as of 1 January 1978 with his next eligibility for review being January 1983.

It was moved by Mr. Neis that the Board grant a 7% increase in the amount of \$840 per year to Ms. Smith, bringing her annual salary to \$13,392 effective 1 January 1978. This motion seconded by Mrs. Bradley and carried unanimously.
