The Board considered a recommendation from Nancy Lignitz and Administrative Judge James W. tone activated
receivers

Travis Brann, emergency preparedness coordinator, appeared before the Board to recommend the acceptance of the bid from Conrad Company, Inc. on tone activated receivers in the total bid amount of \$5,585.50. Mr. Brann points out that the total cost to Douglas County for this project will be \$441.15 and the balance is to be paid through federal matching funds and contributions from the various school districts where these tone activated receivers will be placed. After discussion on Mr. Brann's recommendation it was moved by Mr. Neis that it be approved, seconded by Mrs. Bradley, and carried unanimously.

Ambulance: app.
Bid accepted for
remodel work to be
done on Ambulance
Building

Ted McFarlane, Manager of the Douglas County Ambulance Service, appeared before the Board to recommend the acceptance of the low bid for some remodeling work to be accomplished within the building which houses the ambulance service. The low quote received is from Don's Tile & Floor Covering in the amount of \$1,952.75. The bid includes the materials and labor for installing new carpet in the office area and new vinyl in the upstairs area except the sleeping rooms. After discussion it was moved by Mr. Neis that the recommendation be approved with the amount to be paid from the ambulance budget, seconded by Mrs. Bradley, and carried unanimously.

Purchase 3 sets of
uniforms for 17
employees

Mr. McFarlane then presented a recommendation for the purchase of three sets of uniforms for seventeen employees to be purchased from the Unitog Company. Mr. McFarlane points out that all uniforms have been supplied by Unitog Company for the past three years, and continuing to purchase from them will maintain continuity in our uniform supply. The price quoted by Unitog per set is \$22.41 for 51 sets for a total cost of \$1142.91. After discussion it was moved by Mr. Neis that this recommendation be approved, seconded by Mrs. Bradley, and carried unanimously.

direct refund of over
payments

Mr. McFarlane requested that the Board allow the Manager of the Ambulance Service to draw checks upon the ambulance service bank account which is currently held at the Douglas County State Bank for one additional purpose, that purpose to be to provide a mechanism for direct refund of over payments to accounts receivable, thereby removing the necessity for these refunds being paid by the drawing of a voucher through the Clerk's office and the subsequent charge to the ambulance budget. After review of this request it was moved by Mr. Neis that the Board agree to give the Manager of the Ambulance Service the authority to draw checks upon the ambulance service bank account for the purpose of a direct refund of over payments to accounts receivable. This motion seconded by Mrs. Bradley and carried unanimously.

Sheriff Rex Johnson appeared before the Board to present a quote for the purchase of ten foul weather jackets for the use of the Sheriff's auxiliary to be purchased from the U.S. Uniform Company of Kansas City, Missouri, at a price of \$39.75 each or a total price of \$397.50. After discussion of the need for these jackets it was moved by Mrs. Bradley that this purchase be approved, seconded by Mr. Neis, and carried unanimously.

Res. #HR-78-1-19, app.
Establishes salaries
of certain elected
officials & counselors

The Board considered Home Rule Resolution No. HR-78-1-19 which is a resolution under the authority of K.S.A. 1977 Supp. 19-101a which establishes the annual salaries of certain elected county officials and county counselor. By this resolution the Board declares the following salaries to be effective 1 January 1978 for the respective county officials of Douglas County, Kansas, as shown:
