The Board of County Commissioners of Douglas County met in regular adjourned session with all members of the Board present.

Approved the minutes of the meeting of February 15, 1978.

Appraiser Darwin Rogers notified the Board that Sue Alldredge terminated February 13, 1978.

The Board held interviews on the appraiser's position with the following individuals: Mary Ann Chamberlin, Harry Bradford, Fred Purvis, Roy F. Good, Gary Schnellbacher, Donald Gordon, and David Chartier.

The Board met with Darwin Rogers, county appraiser, Virginia Lomax, and representatives of the township appraisers to discuss the property valuation manual for appraised valuation on farm equipment and some suggested problems which had arisen in using that manual. It was agreed after the discussion that the Board would contact the State Department of Property Valuation to meet with them and representatives of those who met with us today to discuss this matter regarding the current year valuation and the development of state manuals for next year and beyond in an effort to correct those errors and voids which appear in the manual as it presently exists.

No further business, the Board adjourned to meet on Wednesday, February 22, 1978. There will be no meeting on Monday, February 20, 1978, as it is a legal holiday.

The Board of County Commissioners of Douglas County met in regular adjourned session with all members of the Board present.

Approved the minutes of the meeting of February 16, 1978.

The Board approved Commissioners Cancellation Order No. 1749. Order is on file in the office of the County Clerk.

Delbert Mathia, county clerk, appeared before the Board to request an increase in salary for Lois McGovern, bookkeeper in his department, based upon a merit review on the anniversary of her fifth year with Douglas County. Mr. Mathia recommends that Mrs. McGovern be increased to the top of the scale for persons in her classification for 5 to 10 years which is \$738 per month to be effective 1 February 1978. After discussion it was moved by Mrs. Bradley that this recommendation be approved, seconded by Mr. Neis, and carried unanimously.

Kathy Smith, Valleyview Administrator, notified the Board of the following terminations: Joyce A. Weigel on January 18, Barbara D. Daniels on February 8, and Robert L. Steele on February 10, 1978.

It is recommended by Kathy Smith that Linda Rinke be raised from \$2.96 per hour to \$3.00 per hour effective 25 February 1978, that Bertha Demby be raised from \$2.95 per hour to \$3.00 per hour effective 25 February 1978, and that Viola Born be raised from \$2.96 per hour to \$3.00 per hour effective 25 February 1978, all based upon economic adjustment. Also Ms. Smith recommends that the beginning salary for the position of med aide be set at \$2.85 instead of the previous \$2.90 per hour. After discussion on the matter it was moved by Mrs. Bradley that this recommendation be approved, seconded by Mr. Neis, and carried unanimously.

Ms. Smith recommended a six-month increase for merit for David B. Peterson, laundry assistant, from \$2.65 per hour to \$2.79 per hour effective 11 February 1978. After discussion it was moved by Mrs. Bradley that this recommendation be approved, seconded by Mr. Neis, and carried unanimously.

Ms. Smith recommended hiring for Valleyview as follows:

(1) To fill the position of nurses aide, full time, Joyce M. Goings, at the rate of \$2.65 per hour having begun work on 15 February 1978.

(2) To fill the position of nurses aide, full time, Patty M. O'Berg, at the rate of \$2.65 per hour having begun work on 17 February 1978.

(3) To fill the position of nurses aide, full time, Stephen E. Fitch, at the rate of \$2.65 per hour having begun work on 21 February 1978.

After review of these recommendations it was moved by Mrs. Bradley that they be approved, seconded by Mr. Neis, and carried unanimously.
