At the request of Dean Sanderson, director of public works, it was moved by Mrs. Bradley that the Board agree to go into executive session for approximately one-half hour, from 4:30 p.m. to 5:00 p.m., on 27 February 1978 for the purpose of discussing with Mr. Sanderson some matters relating to his position with Douglas County. Motion was seconded by Mr. Neis and carried unanimously.

Dean Sanderson, director of public works, appeared before the Board to recommend the acceptance of a Supplemental Agreement Change Order No. 1 to an agreement dated 22 January 1976 between the Board of Commissioners of Douglas County, Kansas, and Finney & Turnipseed, consulting engineers, Topeka, Kansas, with reference to field surveys, designs, plans, and specifications for approximately one and one-half miles of grading and a bridge on FAS Route 212 beginning immediately west of an intersection with FAS Route 1273 in Douglas County, Kansas. This supplemental agreement would add the following clause to Article I, The Engineer Agrees:

Add 6.(a) To prepare plans for the improvement of Highway US-40 at the intersection with the Project by providing turning lanes and passing lanes on Highway US-40. Such improvement to be similar to that indicated by print of drawing prepared by the Kansas Department of Transportation dated December 1977 and transmitted to the Engineer and the County by Kansas Department of Transportation letter dated December 23, 1977.

This supplemental agreement would also add the following clause to Article III, The Parties Hereto Mutually Agree:

Add 7. (a) That the Engineer will accept compensation for services setforth in Article I,6. (a) of this change order at salary costs plus one hundred percent of salary costs plus out of pocket expenses at the following rates:
