Jim Tate, data processing coordinator, appeared before the Board to recommend the purchase of a terminal stand, No. 4961, to be provided by Data Print, Inc., Kansas City, Missouri. The stand dimensions are 30" x 45" x 26½". The quoted price is \$175.50 with delivery indicated within three to six weeks. After discussion it was moved by Mrs. Bradley that this quote of Data Print, Inc. be accepted, seconded by Mr. Neis, and carried unanimously.

County Attorney Mike Malone appeared before the Board to make a recommendation on the hiring of an assistant to the county attorney's office that would be described as juvenile court attorney. The responsibilities of this individual include preparation and presentation of all juvenile matters in juvenile court. Mr. Malone recommends the appointment of Robert D. Kroecker to this position to be hired as an independent contractor at an annual rate of \$7500 to have begun work on 6 March 1978. After complete discussion on this matter it was moved by Mr. Neis that this appointment be approved, seconded by Mrs. Bradley, and carried unanimously. It is intended that this amount be paid from the economic line item of the commissioners budget.
