Dean Sanderson, director of public works, appeared before the Board to recommend the publishing of a notice to bidders for the purchase of two heavy duty dump trucks for use in the public works department. Mr. Sanderson recommends that this notice be published on the 15th of March and 29th of March in the paper of record for Douglas County. He also recommends that bids be received at the office of the director of public works until 10:00 a.m., C.S.T., on Wednesday, 5 April 1978, at which time the bids will be publicly opened in the office of the Board of Douglas County Commissioners. After discussion it was moved by Mr. Neis that this notice to bidders be approved and so published, seconded by Mrs. Bradley, and carried unanimously.

The Board noted receipt of a check in the amount of \$1043 from USF&G Company which is the proceeds from a claim for water damage which occurred during the reroofing of the courthouse by the Vincent Roofing Company. This amount is determined based on a letter from the B. A. Green Construction Company to the architects Peters, Williams & Kubota which indicates various prices for the repairing of plaster damage within the interior of the courthouse in the total amount of \$1043. This check is to be paid in the revenue sharing fund and is to be used as a portion of the future payments for the remodeling work in the old Douglas County Courthouse.
