The Board considered recommendations from Sheriff Rex Johnson on two appointments to the position of corrections officer to replace individuals who are resigning from that department. The first of these recommendations is for Russell N. VanNess to fill the position of corrections officer to begin work on a full time basis 20 March 1978 at the suggested starting salary of \$670 per month. It is pointed out that Mr. VanNess had begun work on a part-time basis on 13 March 1978 for the purpose of training. The second recommendation is for John C. Gilroy in the position of corrections officer to begin work on 15 April 1978 at the suggested starting salary of \$670 per month. After review and discussion on these recommendations it was moved by Mrs. Bradley that they be approved, seconded by Mr. Neis, and carried unanimously.

Rural Water:
2 applications
for road crossings
with water lines

Tom McGee, engineering division manager, appeared before the Board to present two applications for road crossings with water lines from Douglas County Rural Water District No. 3 to the Board of Commissioners of Douglas County, Kansas. The first of these applications is to lay 3" PVC plastic water line across Douglas County Road 432 approximately 50 feet East of the Northwest corner of Section 3, Township 12, Range 18, in Douglas County, Kansas. The second application is to place 3" PVC plastic water line across Douglas County Road No. 1025 at a point approximately 150 feet East of the Southwest corner of the Southeast quarter of Section 12, Township 12, Range 17, in Douglas County, Kansas. On the basis of these two applications Mr. McGee recommends to the Board that two separate resolutions be adopted granting permission to construct these lines as requested. After discussion it was moved by Mr. Neis that these resolutions be approved granting approval as requested, seconded by Mrs. Bradley, and carried unanimously.

Res. # 78-10

Regarding unredeemed
real estate from
del. tax sale

The Board considered Resolution No. 78-10 whereas K.S.A. 79-2801 requires that in all cases in which real estate has been or shall be sold and bid in by the county at any delinquent tax sale, and shall remain unredeemed on the first day of September of the third year after such sale, or any extension thereof, the Board of County Commissioners shall order the County Attorney or the County Counselor to institute an action in the District Court in the name of the Board of County Commissioners, and whereas the Board finds that there is real estate in that status having an aggregate of assessed valuation of \$10,000 or more. It is thereby resolved by this document that the Board of County Commissioners of Douglas County, Kansas direct the County Counselor of
