The Board reviewed a recommendation from James Paddock, administrative judge, which indicates to this Board his approval for a request for an increase in salary for the Director of Volunteers in Court, Nancy J. Lignitz, upon the two-year anniversary of her employment with Douglas County. It is recommended that Ms. Lignitz's present salary of \$946 per month be increased at the rate of 6% to \$1003 per month effective 1 May 1978. After discussion it was moved by Mrs. Bradley that this recommendation of the administrative judge be approved, seconded by Mr. Neis, and carried unanimously.

Tom McGee, engineering division supervisor, came before the Board to recommend the submittal of an application to the Division of Water Resources of the State Board of Agriculture to make a channel improvement at the proposed construction site at Douglas County Bridge No. 03.80N-12.05E across West Tauy Creek at a location in the Northwest quarter of Section 35, Township 14 South, Range 19 East, Douglas County, Kansas. The purpose of this channel improvement is to improve the water course at this proposed bridge site. It is noted that this application is forwarded with the signatures of all adjoining landowners indicating their approval. After discussion and review it was moved by Mrs. Bradley that this application be forwarded, seconded by Mr. Neis, and carried unanimously.

Mr. McGee then presented a utility agreement on Bridge Project No. 09.00N-21.38E between The Kansas Power and Light Company and the Board of Commissioners of Douglas County which agreement relates to provisions of K.S.A. 17-1901 as to the necessity for movement of utility equipment and facilities which are located on county right-of-way. The agreement indicates that relocation of existing facilities which are currently located on private easement will be paid for by Douglas County and that those facilities within county right-of-way will be moved at utility company expense, and that the construction or alterations of the company's facilities shall be completed within thirty days after the county furnishes to the company the required information. After review of this agreement it was moved by Mr. Neis that this utility agreement be approved, seconded by Mrs. Bradley, and carried unanimously.
