After review it was moved by Mrs. Bradley that this order be adopted and that those lands previously released by Douglas County Rural Water District No. 2 be therefore attached to Douglas County Rural Water District No. 4, seconded by Mr. Neis, and carried unanimously.

*Extension Council:  
Discuss 1979  
budget.*

The Board met with members of the Douglas County Extension Council, represented by Carl Spray, chairman, and with Mr. Richard F. King, Jr., who is representing the Director of Extension at Kansas State University, to discuss the budget for the extension council for the period January 1, 1979 thru December 31, 1979. After a complete review of the budget as it was presented which totaled \$179,420 and which included an appropriation of the Douglas County tax funds of \$129,671.43, it was moved by Mr. Neis that the budget be adopted and that the county budget appropriations be so set. Motion seconded by Mrs. Bradley and carried unanimously by all five members of the group voting in accordance with the terms of K.S.A. 2-610.

Costs incurred by  
Appraiser's office*

The Board considered Resolution No. 78-17 which in accordance with the terms of K.S.A. 19-436 requires the Board of County Commissioners to determine the total costs to be incurred by the Douglas County Appraiser's office and itemize and identify the same in the budget of the County; and whereas, said statutes provide that the Board of County Commissioners give public notice that all taxes levied to pay the costs of the County Appraiser's office are exempt from the aggregate tax levy limitation imposed under the provisions of K.S.A. 79-5001 to 79-5016 inclusive. It is therefore resolved by this document that public notice be given as required by K.S.A. 19-436, that the total costs to be incurred in operating the office of the County Appraiser will be \$175,000 for Fiscal Year 1979, and that all taxes levied to pay this cost shall be exempt from the aggregate tax levy limitation of Douglas County, and if within sixty days after the last publication of this notice a petition signed by electors of Douglas County equal in number to not less than five percent of the total qualified electors of the County is filed in the office of the County Election Officer requesting an election thereon, such costs shall be within the aggregate tax levy limitation of the County unless a proposition to exclude the same from such limitation is submitted to and approved by a majority of the electors of the county voting at an election called and held thereon. If within such period no sufficient protest is filed or if the electors approve such proposition at an election called and held thereon, that portion of the tax levies of such county which is levied for the purpose of paying costs incurred by the county in complying with the provisions of K.S.A. 19-430 et seq. shall not be included in computing the aggregate tax levies of the county and as exempt from the limitations imposed under the provisions of K.S.A. 79-5001 to 79-5016 inclusive. After review of this resolution it was moved by Mrs. Bradley that it be adopted and published, seconded by Mr. Neis, and carried unanimously.

*Agreement: app.  
Coop. child support*

The Board considered a cooperative child support reimbursement agreement. The agreement is entered into by the Secretary of the State Department of Social and Rehabilitation Services, the County Attorney for the County of Douglas, and the Board of County Commissioners of Douglas County. The agreement is entered into so that the County Attorney and the Board of Commissioners can assist the Secretary of Social and Rehabilitation Services in providing the services necessary to secure the support for children. A copy of the agreement which remains on file in the commission office, spells out all the terms and obligations of the parties thereto. After a complete review of the document by the Board and by County Counselor Dan Young, it was moved by Mrs. Bradley that this contract be executed, seconded by Mr. Neis, and carried unanimously.

No further business, the Board adjourned to meet on Wednesday, May 17, 1978.
