Travis Brann, emergency preparedness coordinator, appeared before the Board to review with the Board a Mutual Aid Agreement for Civil Defense Purposes between Johnson County and Douglas County, Kansas, which agreement is entered into by virtue of the planning requirements set forth in the Kansas Emergency Preparedness Act of 1975, K.S.A. 48-928(c) and 48-929(d). The agreement spells out the mutual obligations for aid between the two counties in the event of a man made or natural disaster in which situation mutual aid may be requested. After complete discussion it was moved by Mr. Neis that this mutual aid agreement be executed by Douglas County. It being noted that it had been previously signed by the Commissioners of Johnson County. This motion seconded by Mr. Whitenight and carried. A copy of this agreement shall remain on file in the commission office.

Tom McGee, engineering division manager, appeared before the Board to recommend the acceptance of Change Order No. 1 on Douglas County Bridge and Grading Contracts for Consolidated Project No. 77-2. This change order affects the contract between the Board of Commissioners of Douglas County and Midwest Construction Company, Inc. On Bridge No. 01.50N-12.43E adjustments in the following categories provide a net increase of \$398.90, bringing the final contract price on said bridge to \$52,442.40: Class I Excavation, Class AAA Concrete, Steel Piles, Steel Piles (Cut Off), and Steel Piles (Splices). On Bridge No. 05.10N-22.00E adjustments in the following classifications which brings about a net decrease of \$33, bringing the final contract price to \$47,102.60: Class I Excavation, Class II Excavation, Steel Piles, Steel Piles (Cut Off). These two changes bring the total final contract price to \$99,545 and it is noted that the contractors stipulate that if awarded both bridges, a \$1000 deduct would apply. After review it was moved by Mr. Neis that this change order be approved, seconded by Mr. Whitenight, and carried.

At the hour of 10:00, the Board heard items from the Planning Commission meeting of May 24, 1978. Planning Director Roger Hedrick and staff, David Guntert and Linda Finger, appeared before the Board to present Item No. 12 from the agenda of the Planning Commission meeting which refers to a Conditional Use Permit for what is known as the Dunbar Burning Pit. The request is to allow the burning pit, generally described as being located southeast of the intersection of East 31st Street and Haskell Avenue. The request is submitted by W. A. Dunbar and Son. The item comes forward to this Board from the Planning Commission with unanimous approval, subject to the following conditions:

- (1) That all necessary local, state, and federal permits be acquired; and,
- (2) The CUP be reviewed by the Planning Commission in June 1979.

After complete review and discussion it was moved by Mr. Neis that this Board concur in the recommendation of the Planning Commission subject to the conditions as shown. This motion seconded by Mr. Whitenight and carried.
