After discussion amongst the Board, it was agreed that said applicant would be notified of this Notice of Objection and provided with an opportunity for hearing before this Board, if he so desires.

Ted McFarlane, ambulance manager, appeared before the Board to recommend the rehiring of James O. Burns in the position of EMIC-T as a temporary part-time position. This position is projected to last only two months. The Board made note of a correspondence from Robert A. Cook, P.E., Resident Engineer, Department of Transportation, with reference to Bridge Project No. 23 BRS 508 (10) which is a bridge being constructed by Beach Construction, Inc. in Douglas County. This correspondence forwards to this Board for review a change in plans and construction which generates a net decrease in the amount of \$608.30 based on adjustments in Class I and Class II Excavation, Bearing Devices, and Steel Pile and Steel Pile Cutoff. After review it was moved by Mrs. Bradley that this change order be approved and forwarded back to Mr. Cook as requested, seconded by Mr. Neis, and carried unanimously.

Tracts 33 & 38

The Board reviewed correspondence presented to it by Mr. Raymond Shaffstall, acquisition agent for Kansas Department of Transportation, with reference to Tracts No. 33 and 38 on the Clinton Parkway Project No. 23 AHL 1593 (2). The following information is included in this packet of documents on both Tract No. 33 and 38: Deed, Contract, Voucher, Copy of Offer Letter, Acquisition Report, and Negotiator Statement. The documentation on Tract No. 33 indicates that a just compensation in the amount of \$10,700 is to be paid based upon an agreement between Robert G. Billings and Douglas County and on Tract No. 38 an amount of \$9,765 to be paid based upon agreement between Robert G. Billings, John McGrew and Jill McGrew, and Douglas County. After review of these documents it was moved by Mrs. Bradley that they be executed by the chairman of the Board and approved, seconded by Mr. Neis, and carried unanimously.

No further business, the Board adjourned to meet on Thursday, June 29, 1978.
