Based upon the Board of Commissioners letter to the City of Lawrence of March 17, 1977, which letter states our agreement to fund the 35% of the 30% local share of North Iowa Street expansion project, the Board reviews a letter from Robert G. Cutter, P.E., Urban Systems Engineer of the Kansas Department of Transportation. This letter from Mr. Cutter refers to Project 23-M-3400 (001) Second Street, Iowa Avenue and Lakeview Road, City of Lawrence, Douglas County. The letter indicates that a low bid has been received for this project from M. W. Watson, Inc. and Hamm Asphalt, Inc., joint venture, in the total amount of \$2,095,651.60. It is recommended by the Department of Transportation that this bid be accepted by the City of Lawrence. The letter is forwarded to this Board by the City of Lawrence seeking our concurrence in the total project cost and the 30% local share which amounts to \$704,138.94. Of this amount the City's share is \$457,690.31 and Douglas County's share is \$246,448.63. After discussion it was moved by Mrs. Bradley that the County agree to fund its portion of the local share in the amount of \$246,448.63 which is to be drawn from the special highway improvement fund and the special bridge fund. Motion seconded by Mr. Neis and carried unanimously.

The Board reviewed a correspondence to Karl D. Hockenbarger, assistant planner of the Criminal Justice Planning Committee of the Governor's Committee on Criminal Administration. This letter is from Michael J. Malone, Douglas County Attorney, and Peter A. Whitenight, Chairman of the Douglas County Commission. This letter is designated to indicate concurrence in two aspects of change to the grant application which has been submitted to GCCA for support funding for the District Attorney's office in Douglas County. The letter indicates first an understanding that the total amount of the grant is increased by \$2,000 to cover the increased statutory salary of the District Attorney, and secondly, that the County Commission agree to provide a local match in the amount of \$648.10 as a 5% local match in support of this grant. After discussion it was moved by Mrs. Bradley that this letter be approved by the Board of Commissioners and signed by its chairman and forwarded to Mr. Hockenbarger, seconded by Mr. Neis, and carried unanimously.

Tom McGee, engineering division manager, appeared before the Board to inform the Board that Bridge No. 06.18N-23.01E in Douglas County was reported to have collapsed. This report was made to the Douglas County Public Works Department on 28 June 1978 by Richard W. Rodewald, Route 1, Eudora. The cause of the collapse is unknown at this time. Mr. McGee informs the Board that the road has been barricaded and marked ROAD CLOSED - BRIDGE OUT as of 28 June 1978.

Dan Young, Douglas County Counselor, reported to the Board the filing of a condemnation action, Case No. CV 32247 in Division No. 2 of the District Court of Douglas County, Kansas. This case was filed at 11:25 a.m. on 29 June 1978, and is to exercise the power of eminent domain to acquire easements to lands or interests or rights therein, and other property rights necessary for the construction, alteration, and widening of roads and highways, in accordance with statutes of the State of Kansas. The improvement under consideration in this case if the road to be known as Clinton Parkway designated as Project No. 23 AHL 1593 (2).

The Board noted receipt of a letter from Raymond R. Shaffstall, acquisition agent from the Kansas Department of Transportation, dated 29 June 1978, with reference to the purchase of right-of-way on Project No. 23 AHL 1593 (2) of Douglas County. This letter forwards to this Board for payment the completed acquisition documents on Tracts 30 and 35 on the above referenced project. On Tract No. 30 the following documents appear: (2) Corporation Deeds, Partial Release of Mortgage from M. Clevenger, Contract, Temporary Easement, Voucher, Acquisition Report, and Negotiator Statement. On Tract No. 35 a Deed, Partial Release of Mortgage, Contract, Voucher, Acquisition Report, and Negotiator Statement. It is indicated in the letter that an additional partial release of mortgage will be released from the General Council of the Assemblies of God on Tract No. 30, and on Tract No. 35, Mr. Robert Billings, the owner, is to furnish Counselor Dan Young with a proof of release of Federal Tax Lien. The documentation has been reviewed and approved by Counselor Young and he recommends that the payment of \$2,360 be made on Tract No. 30 and the payment of \$3,300 be made on Tract No. 35 in accordance with the terms of the vouchers enclosed. After discussion it was moved by Mr. Neis that these vouchers be approved and forwarded for payment from the special highway improvement fund as recommended by Counselor Young, seconded by Mrs. Bradley, and carried unanimously.
