Wayne Kellum, zoning administrator, appeared before the Board to present the second quarter report for 1978 of the transactions which have taken place in his department. Mr. Kellum indicated the issuance of forty-nine building permits for new homes or additions to residences with a total declared value to be \$1,723,525. Permits were issued for five mobile homes for \$29,300 and sixteen fireworks for \$160. The total estimated value for the three months period is \$1,752,825 and the total fees collected by his department is \$1,046.50 This figure compares to a second quarter report of 1977 of a total estimated value of \$1,484,200. A copy of this second quarter report will be on file in the commission office.

The Board reviewed a correspondence from Ted Mintun, Chief of Social Services of the State Department of Social and Rehabilitation Services. This correspondence forwards to this Board for its consideration (1) modifications to the present contract which terminates that contract as of 19 June 1978, and (2) a new contract from 20 June 1978 through 19 December 1978. The modification to Donor Contract No. 782 decreases the donated funds on that contract in the total amount of \$2,406.50 which was previously committed under that contract for the purchase of day care services for families in Douglas County. The new donation contract which commences the 20th day of June 1978 and extends to the 31st of December 1978 is for a total committment of \$4,793.50 as donated funds with \$2,396.75 to be paid between 1 July 1978 and 10 July 1978, and the balance of \$2,396.75 on or before 1 September 1978. These funds will be used in accordance with the terms of the contract for purchase of day care services in Douglas County. Both the modification to Donation Contract No. 782 and the renewal of Donation Contract No. 782 have been executed by Robert C.
