> Mr. Dooley then recommended to the Board the acceptance of the low estimate from Wayne's Body Shop, Inc. in the amount of \$1154.84 for the body repair on public works department truck No. 206 for a Dodge dump truck for body damage in an inter-department accident. After discussion it was moved by Mrs. Bradley that this recommendation be accepted, seconded by Mr. Neis, and carried unanimously.

Mr. Dooley then presented to the Board Change Order No. 1 for Supplemental Agreement on Consolidated Bridge Project No. 77-1, which amends the contract adopted the 27th day of April 1977 between the Commissioners of Douglas County and Bushman Construction Company. This change order makes net adjustments for final quantities of variable materials for use in this project and provides for a net decrease on Bridge No. 01.50N-16.58E in the amount of \$110.34, provides for a net increase on Bridge No. 02.00N-16.52E of \$348.52, and provides for a net increase on Bridge No. 04.00N-20.61E of \$297.33. It is indicated that, therefore, the total final contract amount as adjusted, is \$126,658.51, less five days of liquidated damages at \$140 per day. After review of this change order it was moved by Mrs. Bradley that it be approved, seconded by Mr. Neis, and carried unanimously.

Zoning: app. Request ban on sale of bottle The Board met with zoning administrator Wayne Kellum to discuss further the question raised, by a request from the City of Lawrence, that Douglas County should ban the sale of bottle rockets. After full discussion on the issue it was moved by Mr. Neis that we recommend to the planning commission an amendment to the zoning regulations of Douglas County which would add to Article 9, Section 9-1 (14) a total ban on the sale of bottle rockets in Douglas County. Motion seconded by Mrs. Bradley and carried unanimously.

Jim Williams, architect, presented to the Board Change Order No. 3 and No. 4 Courthouse : app. on the courthouse remodeling project. Change Order No. 3 is with Norris Ch. order #13 to Change wallin roomo 10441.05 Brothers, Inc. and is a net addition of \$368 for revisions to the wall between Room 104 and 105 in accordance with the contractor's letter of August 16, 1978. Change Order No. 4 is with B. A. Green Construction Co., Inc. on General Contract No. 3, presenting a net addition of \$3,076 which includes a revision to the wall between Room 104 and 105 in the amount of \$1,879 and the addition of upper and lower cabinets among the west wall in Room 104 in the amount of \$1,197, both in accordance with the contractor's letter of August 11, 1978. After review of Change Order No. 3 with Norris Brothers, Inc. and Change Order No. 4 with B. A. Green Construction Co., Inc., it was moved by Mrs. Bradley that they be approved, seconded by Mr. Neis, and carried unanimously.
