That a copy of the petition, and notice of the time and place of hearing on said petition was mailed to the Chief Engineer of the Division of Water Resources of Douglas County, Kansas, on August 24, 1978; that notice was published in the Lawrence Journal World, a newspaper of general circulation in Douglas County, Kansas, located in Lawrence, Kansas, on the 24th day of August, 1978, all in accordance with Chapter 82a, Article 6, Kansas Statutes Annotated, as amondod.
