The Board considered Change Order No. 5 to General Contract No. 3 on the Douglas County Courthouse Remodeling project. This contract between B. A. Green Construction Company and the Board of Commissioners of Douglas County is amended by a net reduction of \$963.39, which is based upon the fact that the actual amount for signs for the building will be \$1336.61, which is \$963.39 less than the \$2300 which was allowed for this activity in the contract. Including this net deduction the new contract sum total is \$208,954.61. After discussion it was moved by Mrs. Bradley that this change order be approved, seconded by Mr. Whitenight, and carried.
