Mike Dooley, director of public works, appeared before the Board to present a status report on the improvement of the Stull road. As a portion of this report it is recommended by Mr. Dooley, having reviewed the situation with County Counselor Dan Young, that the Board of Commissioners commence condemnation procedures on the following tracts on subject project know as FAS 23-RS-1347(7): Tract No. 1, Eacock; Tract No. 4, Swallow; and Tract No. 12A & 12B, Williamson. After a complete review of the documentation of the efforts made by the public works department to make a purchase of this right-of-way in accordance with the statements of basis for offer which had been presented to this Board by the appraiser, it was moved by Mrs. Bradley that we accept the recommendation of Mr. Dooley and Counselor Young and proceed with condemnation on the above-named tracts so that this project might move forward in the hope of a November bid letting, seconded by Mr. Whitenight, and carried.

At the advertised hour of 10:00 a.m. the Board opened bids on a variety of equipment and supplies required for the O'Connell Youth Ranch which is to be funded by a GCCA grant in support of this activity. Eight bids were received covering this variety of equipment and, after a brief discussion, it was moved by Mrs. Bradley that the bids be taken under advisement and reviewed by federal funds consultant Ernest Coleman for a recommendation to the Board at a later time, and that Mr. Coleman be authorized, upon approval of the GCCA committee, to proceed with the ordering of the acceptable low bid equipment. Motion seconded by Mr. Whitenight and carried.

Jim Williams, architect with Peters, Williams & Kubota, appeared before the Board to recommend the following payment on the courthouse remodeling project: Application No. 1-Final to Willowridge Landscape and Grading for the sprinkler system, from the period February 1, 1978 to September 6, 1978, in the amount of \$1,662. After discussion it was moved by Mrs. Bradley that this recommendation be approved and paid from 1977 previously obligated general funds, seconded by Mr. Whitenight, and carried.

cover deficit in '79
Title VII Nutrition
Project*

The Board reviewed a correspondence from Rowena Pine, President of the Board of Directors of the Douglas County Planning Council on Services for Aging. In sum, this letter indicates that supplemental funding in support of the Title VII Nutrition Project will not be available for the Fiscal Year 1979 and that a deficit appears in the budget total for this project in the amount of \$36,434. The letter requests confirmation of local funding support for this additional amount so that the program might continue at its present level through the next fiscal year. After a complete discussion it was moved by Mrs. Bradley that the Board commit to provide an amount, not to exceed \$36,500, from contingent revenue sharing funds for the year 1979 which will not be available before January 1979 to provide additional support for this program. This commitment takes into consideration an understanding that the City Commissioners of the City of Lawrence have agreed to review this situation with the Board of County Commissioners and will, perhaps, provide an additional allocation of revenue sharing funds in support of this projected additional need. Motion seconded by Mr. Whitenight and carried.

No further business, the Board adjourned to meet on Monday, October 2, 1978. There will be no meeting on Thursday, September 28, due to Mr. Neis being out of town and Mrs. Bradley will be attending the Northeast Kansas County Officials Association meeting at Troy.
