These recommended reductions will not decrease the gross pay of the employees involved. All regular hours worked in excess of 46 in a 7-day work period will be paid at the rate of 1½ times the regular hourly wage. Understanding that all of these employees are routinely scheduled for an average of 56 hours per week, they will be paid an average of 10 hours overtime weekly. It is recommended that these changes become effective with the pay period beginning October 28, 1978. After discussion and review it was moved by Mrs. Bradley that these recommended changes per hourly salary levels for the ambulance service be approved, seconded by Mr. Neis, and carried unanimously.

Personnel shelfine. The Board reviewed the salary of Charles Nichols, an employee in the parks Charles Michels County Mr. Nichels automate allowing of his employment with Douglas County. Mr. Nichols' current salary is \$647 per month. After brief discussion it was moved by Mrs. Bradley that his salary be increased approximately 6%, to the new rate of \$686 per month, effective with the pay period beginning October 28, 1978, seconded by Mr. Whitenight, and carried.

Jim Williams, representative of the architectural firm of Peters, Williams & Kubota, appeared before the Board to recommend the execution of Certificate of Substantial Completion with the Dover Elevator Company for the construction of elevator and cab for the Douglas County Courthouse Remodeling Project. The date of issuance for this certificate is October 23, 1978. After discussion it was moved by Mrs. Bradley that this certificate be executed by the Board, seconded by Mr. Neis, and carried unanimously.

Director of Public Works Mike Dooley appeared before the Board to point out that in August 1977 two culverts were installed at the request of Mr. George Noble, Route 5. Subsequently, four different bills have been submitted to cultures for George Mr. Noble and no response has been received. It is Mr. Dooley's recommendation that this matter be referred to County Counselor Day Young to initiate legal proceedings for collection of this bill. After review it was moved by Mrs. Bradley that we forward this item to Counselor Young, seconded by Mr. Neis, and carried unanimously.
