non-FAS Road System. The agreement covers approximately 94 bridges which shall be designated by the county who shall compensate the engineer at the rate of \$74.50 per bridge inspected. The agreement sets out the obligations of the engineer and of the county and those items mutually agreed upon by both parties and within the agreement it is specifically stated that this agreement shall become effective upon receipt of written notice to the county from the Secondary Roads Department of the Kansas Department of Transportation that the inspection services, as herein described, have been approved for federal funding assistance under the terms and provisions of the Federal Highway Program or upon written notification to the engineer by the county to proceed with the inspection. The engineer agrees to serve as a representative of the county during the project application processing and review with the Kansas Department of Transportation. Let the record show that the agreement has been executed by Douglas W. Flatt, President, Cook, Flatt & Strobel. After complete review and discussion it was moved by Mr. Neis that this agreement be approved, seconded by Mrs. Bradley, and carried unanimously.

(3) In connection with Item No. (2), Mr. Dooley recommends that the Board approve a Request for Construction Project Off-System Roads Program which applies to the development of surveys and plans in the amount of \$7,003. This is the total amount projected for off-system bridge inventory, appraisal, and coding for approximately 94 bridge sites. This request indicates that surveys and plans will be developed by Cook, Flatt & Strobel, Engineers, and the document resolves that Douglas County hereby pledges to the Department of Transportation that the local matching funds will be available for the completion of this project. After complete review it was moved by Mrs. Bradley that this request be approved and forwarded to the State Department of Transportation, seconded by Mr. Neis, and carried unanimously.

Share cost of a  
Safety Technician  
to serve both City  
& County

The Board reviewed a correspondence from Buford Watson, City Manager of the City of Lawrence, which is the result of a number of conversations held prior. In Mr. Watson's correspondence it is proposed that, since the City is in the process of hiring a new full time Safety Technician to assist Risk Administrator Phil Leonard, approximately 50% of the time of this individual might be available to Douglas County for our use in our risk management program in reference to Workmen's Compensation claims. The proposal indicates that this Safety Technician would be a city employee, operating under the direction of city staff and under the direct supervision of Risk Administrator Phil Leonard. Fifty percent of the time worked by this Safety Technician would be allocated to Douglas County. After complete review and discussion of this proposal it was moved by Mrs. Bradley that it be approved and that the county stand ready to pay its proportionate share of approximately \$6400 during the budget year 1979 from the county general fund, seconded by Mr. Neis, and carried unanimously.

No further business, the Board adjourned to meet on Wednesday, December 6, 1978.
