Commission : COL and mout review raises for 1979

The Board reviewed proposed Commissioners Memo No. 15 which is to be directed to all elected officials, department heads, and employees of Douglas County on the subject of cost-of-living and general salary increase for the year 1979. After complete review of this proposed memo it was moved by Mr. Neis that the following policy be adopted for salary increases for 1979:

(1) There will be a cost-of-living increase paid to all employees. Any employee with a gross monthly salary below \$750 will receive a flat \$30 per month increase. Any employee at the salary of \$750 and above will receive an increase of 4% over their ending 1978 gross monthly salary.

(2) Each department will be given an allowance of 2.5% of its total monthly gross salaries for all the employees in that department which amount may then be distributed amongst the departmental employees at varying rates depending upon a complete merit review of the department personnel. These merit reviews will be conducted as soon as possible by the County Officials and Department Heads and the results and recommendations derived therefrom shall be presented to the Board of Commissioners as soon after the first of the year as possible. These annual merit reviews for all employees will be conducted instead of the previous policy of periodic reviews for merit on the particular employee's anniversary date of employment.
