Banks used by
certain Co. officials

Res. #79-5:

Savings Assoc.
for idle funds

The Board considered further Resolution No. 79-5 which resolution relates to the statutory authority given pursuant to K.S.A. 17-5002 to invest its idle funds in shares or savings deposits in each of any one or more state or federally chartered savings and loan associations which are located in Douglas County. This resolution authorizes the investment of idle funds in shares or savings deposits in each of the following savings and loan associations in Douglas County:

Anchor Savings Association
Capitol Federal Savings and Loan Association
Lawrence Savings Association

provided, that no investment of such funds shall be made in amounts more than that amount which is insured by the Federal Savings and Loan Insurance Corporation. After full consideration of the matter it was moved by Mr. Neis that the resolution be adopted, seconded by Mr. Cragan, and carried unanimously.

County paper
selected for
publications

The Board considered Resolution No. 79-6 which resolution designates the official county papers for publication of legal notices, bills allowed, delinquent real estate tax list and quarterly statements. After discussion on the matter it was moved by Mr. Neis that the Lawrence Journal World be the official county paper for the publication of all legal notices, bills allowed and delinquent real estate tax list and that The Baldwin Ledger publish the quarterly statements. This motion was seconded by Mr. Cragan and the resolution passed unanimously.

for public funds

The Board further considered Resolution No. 79-7 which resolution is the authority to designate bank depositories for public funds as provided by K.S.A. 9-1401 and to require security for such deposits in accordance with said statute and to designate the following banks insured under the Federal Deposit Insurance Corporation as to the deposits of public monies for Douglas County:
