Bob Duver, Douglas County Weed Director, appeared before the Board to discuss the state plan for musk thistle control. After much discussion by the Board it was moved by Mr. Neis that Douglas County become involved in this plan. It was pointed out that our county has been identified as having sufficient musk thistle acreage to warrant being a part of this plan. Motion seconded by Mr. Cragan and carried unanimously.

Jim Tate, data processing coordinator, appeared before the Board to request merit increases for three of his employees. It was moved by Mr. Neis that the following merit increases be granted effective January 6, 1979:
