Notice for bids  
on 2,4-D

Bob Duver, noxious weed director, appeared before the Board to recommend the approval of Notice to Bidders that sealed bids for the purchase of 34,020 gallons of 2,4-D by the Douglas, Franklin, Jackson, and Shawnee County Noxious Weed Departments will be received at the office of the Shawnee County Noxious Weed Department until 10:00 a.m., C.S.T., February 26, 1979, and then publicly opened in the office of the Shawnee County Weed Department, 1720 Western, Topeka, Kansas, by the Shawnee County Purchasing Agent. It is recommended that this notice be published in the Lawrence Journal World on the 7th and 21st of February 1979. It is understood that of this 34,020 gallons, it is Douglas County's intention to purchase 8,000 gallons of Amine to be delivered no later than April 6, 1979. After discussion on this recommendation it was moved by Mr. Neis that this Notice to Bidders be so published, seconded by Mr. Cragan, and carried unanimously.
