Private road  
Dwayne McCune

Wayne Kellum, zoning administrator, and Dwayne McCune appeared before the Board to request the approval of an easement for a private road for purposes of obtaining a building permit. Mr. Kellum indicates that this request is for an easement 30 feet in width and 300 feet in length, commencing at the Northwest corner of the following described tract: Beginning at a point 2114.12 feet South and 1328.84 feet West of the Northeast corner of the Southeast Quarter of Section 17, Township 14, Range 19; thence South 89° 31' 30" West, 318.62 feet; thence South 0° 00' 58" West, 550 feet to the South line of said Southeast Quarter; thence North 89° 31' 30" East along said South line, 318.62 feet; thence North 0° 00' 58" East 550 feet to the point of beginning, containing in all 4.0 acres, more or less; and continuing in a southerly direction along the West boundary 300 feet. This easement request is to serve a 12 acre tract with only one house to be built in what is commonly known as Timberline Acres but is not a subdivision. After review of this request it was moved by Mr. Neis that the Board approve this private way for the issuance of the building permit for development of a residence on Mr. McCune's property described above, seconded by Mr. Cragan, and carried unanimously.
