Darlene Hill, budget director, appeared before the Board to present Statement of Expenditures and Balances of Budget Appropriations from January 1, 1979 to April 17, 1979, and Statement of Fund Balances as of March 31, 1979.

Mike Dooley, public works director, appeared before the Board with two quotes for an ice machine to be used to furnish ice for public works department, maintenance department, and noxious weed department. Mr. Dooley recommended that the Board accept the low quote of Johnny's Refrigeration for the purchase of a Scotsman MC 30 SWE-1A Ice Machine with a 550 lb. bin capacity in the amount of \$1678. After discussion it was moved by Mr. Neis that this low quote be accepted, seconded by Mr. Cragan, and carried unanimously.

Construct 3 miles
of road on FAS 214*

Mr. Dooley then discussed Douglas County Road 432, FAS No. 214. Mr. Dooley stated that his department has solicited and received proposals from the engineering firms of Cook, Flatt & Strobel and Finney & Turnipseed for preliminary surveys and construction plans for three miles of the above referenced road immediately west of Lecompton, Kansas. This three miles of road is shown on our five year program for calendar year 1980. Mr. Dooley recommended that the Board accept the agreement submitted by Finney & Turnipseed, Consulting Engineers, Topeka, Kansas, for field surveys, designs, plans, and specifications for grading and a bridge on this roadway in the lump sum amount of \$20,500. After discussion it was moved by Mr. Neis that this agreement with Finney & Turnipseed be approved, seconded by Mr. Cragan, and carried unanimously.
