The Topeka Operational Area consists of sixteen northeast Kansas counties which includes Douglas County. This document sets forth the procedures agreed upon by broadcast and local government entities of the Topeka Operational Area, which will permit activation of the Area Emergency Broadcast System by designated local officials. After complete review and discussion it was moved by Mr. Neis that this plan be approved, seconded by Mr. Cragan, and carried unanimously.
