(2) Robin M. Donahey in the position of EMIC-T, at a starting salary of \$1050 per month (\$4.33 per hour), to commence work on July 2, 1979.

(1) A wage adjustment for James Burns from \$900 (\$3.71 per hour) to \$1100 per month (\$4.53 per hour) effective July 30, 1979. Mr. Burns worked for DCAS on a permanent status as an EMT from April 1976 to January 1977. He was rehired on a part-time basis in June 1978. Mr. Burns desires to return on a full time basis with almost 2 years experience as an EMIC.

(2) Promote Michael Welter from the position of EMIC-T at a salary of \$1033 per month to the position of Training Officer at a salary of \$1150 per month effective June 23, 1979. Mr. Welter started his employment with DCAS on August 14, 1978.

After discussion on these requests it was moved by Mr. Neis that they be approved, seconded by Mr. Cragan, and carried unanimously.
