The Board met with Ernest Coleman, federal funds consultant, and Mary J. Stabb, project director, of a proposed grant application to GCCA for a project entitled "Treatment and Prevention of Child Sexual Exploitation and Acquaintance Rape." It is anticipated that the total amount of the project will be \$28,680.96 of which amount \$25,812.86 is requested from GCCA, state contribution of \$1,434.05, and applicant contribution of \$1,434.05. It is clearly understood that the applicant contribution, in this year, and in future years is not intended to be drawn from Douglas County levy funds or revenue sharing funds, but that Douglas County's role in this grant application is purely as sponsor and fiscal agent. The application is for the period January 1, 1980 to December 31, 1980. After a complete review of this application and discussion on Douglas County's role in relationship to it, it was moved by Mr. Neis that we sign the application as an official unit of government authorized to sign and forward to GCCA for their review and potential approval. Motion seconded by Mr. Cragan and carried unanimously.
