Stabb, project director, of a proposed grant application to GCCA for a project entitled "Treatment and Prevention of Child Sexual Exploitation and Acquaintance Rape." It is anticipated that the total amount of the project will be \$28,680.96 of which amount \$25,812.86 is requested from GCCA, state contribution of \$1,434.05, and applicant contribution of \$1,434.05.
