At the hour of 10:00 a.m., the Board discussed planning items with Roger Hedrick, director of the planning department, Linda Finger and David Guntert, staff members. The Board considered Item No. 4 from the Lawrence-Douglas County Planning Commission minutes of October 24, 1979. This item is a final plat of Clinton Cove Subdivision, a proposed residential subdivision in the county. This property is generally described as being located directly north of Clinton Reservoir on the east side of the Corps of Engineers access road to the dam, containing approximately 14.57 acres and is submitted for William J. and Betty Brink. This item comes to the Board with a recommendation for approval from both the planning staff and the planning commission. After discussion it was moved by Mr. Neis that the Board approve this final plan, subject to the following conditions of the planning commission:

(1) That the names of surrounding property owners and the general location map be added to the plat;

(2) That a note be placed on the plat stating that access be limited to the township road, except for Lot 2 which has an existing access point to the Corps Road; (3) That the 15 foot utility easement be changed to a 10 foot utility

(4) That a 35 foot road easement be included on the plat; and, easement;

(5) That a temporary utility agreement be executed.

The next item considered by the Board was Item No. 11 from the Lawrence-Douglas County Planning Commission meeting of October 24, 1979. This item is CUP-8-5-79 which is a request for a Conditional Use Permit to allow construction of a storage building for Rural Water District No. 5 on a one-acre site generally described as being located south and west of the intersections of U.S. Highway 56 and County Road 1029, submitted by Walter M.
