Mr. Dooley then presented the Board Resolution No. 79-36 which resolution relates to authorizing a member of the Douglas County Board of Commissioners and Director of Public Works/County Engineer to execute certain documents on behalf of the county. This resolution authorizes the chairperson of the Douglas County Board of Commissioners, Ms. Beverly Bradley, to execute an application to the Kansas Department of Transportation Safety Coordinating Section for a Highway Safety Project Grant, an agreement with the Kansas Department of Transportation for Project No. RE 80-11-12, and Contractual Provisions Attachment Form DA-146a to said agreement. This resolution also authorizes the Director of Public Works/County Engineer to co-execute the above-mentioned application for a Highway Safety Project Grant and the Certification of Project Applicant known as Special Attachment No. 2 to the above-mentioned project agreement. After discussion it was moved by Mr. Neis that this resolution be approved, seconded by Mrs. Bradley, and carried.

Mr. Dooley then presented the Board a correspondence from Mr. Lynn Burris, Jr., State Liaison Officer of The Kansas State Park and Resources Authority, which requests an Annual Operation and Maintenance Assurance Statement on Wells Overlook Regional Park. This Assurance Statement is required of Douglas County since this project was in part funded by the Bureau of Outdoor Recreation funds. The statement includes a number of requirements for maintenance and appearance of the facility and a certification of non-discrimination in the use of the facility. After discussion it was moved by Mr. Neis that this Assurance Statement be executed and returned to the state for signing by the State Park and Resources Authority, seconded by Mrs. Bradley, and carried.

FAS Route 211

Mr. Dooley then recommended for approval a Request for Construction Project to be forwarded to The Kansas Department of Transportation whereas KDOT is requested to program for construction that portion of FAS Route No. 211 located 0.35 miles south of Northwest Corner, Section 18, Township 13S, Range 20E, thence north 0.35 miles and which includes grading, culverts and bridges for an estimated total for project to be \$320,000. Surveys and plans will be made by Finney and Turnipseed and sufficient funds of Douglas County are now, or will be, available and are hereby pledged to KDOT in the amount and at the time required for the Supplementing of Federal funds available for the completion of this project. After discussion it was moved by Mr. Neis that this Request for Construction Project be approved, seconded by Mrs. Bradley, and carried.
