Mr. Dooley also recommended that the Board approve a quote of Brunson Instruments for a Vemco drafting machine in the amount of \$231.30. After discussion it was moved by Mr. Cragan that these recommendations be approved, seconded by Mr. Neis, and carried unanimously.

Mr. Dooley then recommended approval of a quote from Streeteramet Traffic Data Systems, The Mangood Group, for 4 JR Trafficcounter Model 160 for a total amount of \$760. After discussion it was moved by Mr. Cragan that this recommendation be approved, seconded by Mr. Neis, and carried unanimously. It should be noted that \$206 of this total amount will be reimbursed by the Kansas Department of Transportation under a contract for a county-wide safety study.

Mr. Dooley then advised the Board that pursuant to Douglas County Resolution No. 78-26, dated August 17, 1978, Lecompton Township Board has concurred in the recommendation of acceptance of the rock surfaced roads in The Bluffs Subdivision and further agrees to maintain these roads in accordance with accepted standards. With this information it was moved by Mr. Neis that the Board accept the recommendation of Mr. Dooley to place these rock surfaced roads, known as Rimstone Road and Rimstone Court in The Bluffs Subdivision, in the Lecompton Township Road Mileage with maintenance responsibilities for these roads assigned to the Lecompton Township Board, seconded by Mr. Cragan, and carried unanimously.
