Kathy Smith, Valleyview Administrator, presented the Board three quotes for a Smith Corona, portable, electric, typewriter. LeRoy McDermott, Drug Abuse Coordinator, appeared before the Board and presented Subagreement for Activities & Services Authorized Under Title VI of the Comprehensive Employment & Training Act of Contract No. 1500-610-80-036, which is an agreement between the Kansas Balance-of-State CETA Office, prime sponsor, and Douglas County. By this agreement Douglas County will receive reimbursement allowable costs beginning February 1, 1980 and ending September 30, 1980, in an amount not to exceed \$5317 to fill one participant job slot. After discussion it was moved by Mr. Neis that the Board accept this document, seconded by Mrs. Bradley, and carried.

Gary Shofner, representative of Cook, Flatt & Strobel, Engineers, Topeka, Kansas, appeared before the Board to present and discuss the Engineering Study and Report for Off-System Bridge Inventory and Appraisal for Douglas County, Kansas, prepared by their firm. Those present for the discussion were Tom McGee, engineering division manager; Mike Dooley, public works director; and John Young, engineering technician.

Mike Dooley then asked that the Board reconsider the only bid that was received on February 20, 1980, for the purchase of guard rail with accessories and posts. Mr. Dooley stated that he had checked with two other suppliers for this material and they were both higher than the bid received at bid opening on February 20, 1980, from J & J Metal Products Company, Paola, Kansas. With this information Mr. Dooley recommended that the Board accept the bid of J & J Metal Products Company for the purchase of guard rail with accessories and posts in the total amount of \$14,688.81. After discussion it was moved by Mr. Neis that the minutes of February 20, 1980, in regard to this matter be rescinded, and that the Board accept the recommendation of Mr. Dooley to accept the low quote of J & J Metal Products Company, seconded by Mrs. Bradley, and carried.

Mr. Dooley then recommended for approval a Request for Construction Project to be forwarded to The Kansas Department of Transportation whereas KDOT is requested to program for construction that portion of FAS Route No. 209 located in Section 5, Township 13S, Range 21E at the north city limit of Eudora which includes rehabilitation of bridge over Wakarusa River for an estimated total for project to be \$275,000. Surveys and plans will be made by Finney and Turnipseed and sufficient funds of Douglas County are now, or will be, available and are hereby pledged to KDOT in the amount and at the time required for the Supplementing of Federal funds available for the completion of this project. After discussion it was moved by Mr. Neis that this Request for Construction Project be approved, seconded by Mrs. Bradley, and carried. This is known as Douglas County Project No. 23 RS 509(11).

After discussion it was moved by Mr. Neis that this Notice to Bidders be so published with the bids to be received until 9:00 a.m., C.S.T., on March 19, 1980, seconded by Mrs. Bradley, and carried.
