Bob Duver, noxious weed director, appeared before the Board to recommend the approval of Notice to Bidders that sealed bids for the purchase of 17,648 gallons of 2,4-D by the Douglas, Franklin, Jackson, and Shawnee County Noxious Weed Departments will be received at the office of the Shawnee County Noxious Weed Department until 10:00 a.m., C.S.T., March 24, 1980, and then publicly opened in the office of the Shawnee County Weed Department, 1740 Western, Topeka, Kansas, by the Shawnee County Purchasing Agent. It is recommended that this notice be published in the Lawrence Journal World on the 12th and 19th of March 1980. It is understood that of this 17,648 gallons, it is Douglas County's intention to purchase 4,162 gallons of 2,4-D to be delivered no later than May 1, 1980.
