George Little, data processing director, notified the Board that Alan Swarts will terminate on April 4, 1980. a. Swarts

Bob Duver, noxious weed director, appeared before the Board and recommended Weed Dept. : app. Rurch 2, 4-D to the Board the acceptance of the low bid for 4,162 gallons of 2,4-D which bids were received at the office of the Shawnee County noxious weed director. The low bid for this product is from Pueblo Chemical & Supply, Iola, Kansas, for the following:

(1)	2,000 gallons 2,4-D Amine

(2) 162 gallons 2,4-D Amine \$8.11/gallon in one gallon cans

The total bid is in the amount of \$35,813.82. Five bids were received. It is designated in the Douglas County specifications that this 4,162 gallons of 2,4-D is to be delivered no later than May 1, 1980. After discussion it was moved by Mr. Neis that this low bid be accepted, seconded by Mrs. Bradley, and carried.

Weed Dept. app Mr. Duver then presented figures which indicate the administrative cost per gallon of 2,4-D for the year 1980 is recommended to be set at the rate of Sole price for 0.68 per gallon.
