Third Year Plan

LeRoy McDermott, Douglas County drug abuse coordinator, appeared before the Board to request approval of Douglas County Model Community Prevention System, Third Year Plan. Mr. McDermott recommended the approval of \$1200 from Senate Bill 467 or other county funds. The CETA positions with the Drug Abuse Council will count as local cash match. These items plus previously allocated 1980 revenue sharing funds basically make the required amount for the Third Year Program. After discussion it was moved by Mr. Neis that this request be approved, seconded by Mrs. Bradley, and carried.

Mike Dooley, public works director, appeared before the Board with two quotes for a 1/2 HP pump, for County Well No. 13, known as Alexander Well, located on County Road No. 458. Mr. Dooley recommended that the Board accept the low quote of Patchen Electric & Industrial Supply, Inc., Lawrence, Kansas, in the amount of \$255.75. After discussion it was moved by Mr. Neis that this recommendation be approved, seconded by Mrs. Bradley, and carried.

Report on tower  
at Lone Star

Mr. Dooley then recommended acceptance of the report from Ponzer-Sears-Youngquist, Olathe, Kansas, consulting engineers, regarding the repair and renovation of the valve and tower at Lone Star Lake. Mr. Dooley also recommended that the Board authorize the consultant to proceed with plan development. The total estimated cost for the project is \$80,100 which includes \$12,900 for the installation of the walkway. It was also recommended that the county order and purchase the necessary 20-inch valve to be installed in the tower as delivery of this item requires approximately 14 to 16 weeks. After discussion it was moved by Mr. Neis that the recommendations be approved and that the installation of the walkway will remain an optional item pending on availability of funds, seconded by Mrs. Bradley, and carried.

Discuss storm  
windows

Fremont Hornberger, maintenance supervisor, and Ernest Coleman, federal funds consultant, appeared before the Board for additional discussion of a recommendation made by them and approved in the minutes of March 13, 1980, concerning the apparent low bidder on 139 storm windows for the Douglas County Courthouse. They reported that a visit had been made the previous Thursday to Maryville, Missouri to view an actual installation of the proposed units on a college campus residence building. It was their report that a mistake had been made by their previous recommendation and that the motion should be rescinded because the following three major areas in the original bid specifications will not be met: (1) No stabilizer bars on units over 54 inches in height, (2) no wind checks on all operable sashes, and (3) no quality
