The Board met with members of the Douglas County Extension Council, represented by Dorothy Congrove, chairman, and with Dr. Bob Newsome, who is representing the Director of Extension at Kansas State University, to discuss the budget for the Extension Council for the period January 1, 1981 to December 31, 1981. After a complete review of the budget as it was presented, which totaled \$208,054 and which included an appropriation of the Douglas County tax funds of \$147,201 and reflects approximately a 6% increase, it was moved by Mr. Neis that the budget be adopted and that the
