Buidge Co. app Appl. forch imp (1.95N-30.70E) Mike Dooley, public works director, appeared before the Board to recommend the submittal of an application to the Division of Water Resources of the State Board of Agriculture to make a channel improvement at the proposed construction site at Douglas County Bridge No. 11.95N-20.70E across Little Wakarusa Creek located at the south line of Section 18, Township 13 South, Range 21 East of the 6th Principal Meridian, two miles south and one mile west of the City of Eudora, Kansas. The purpose of this channel improvement is to provide adequate facilities for vehicular traffic and waterway area for stream flow.
