1980 road sealing

Mr. Dooley then presented the Board quotes to furnish and apply roadway sealing for Douglas County for the summer of 1980. Mr. Dooley recommended that the Board accept the low quote from N. R. Hamm Contractor, Inc., Perry, Kansas, in the total amount of \$207,528.85. After discussion it was moved by Mr. Neis that this recommendation be approved, seconded by Mr. Cragan, and carried unanimously.

Mr. Dooley then presented a contract for right-of-way for Bridge No. 01.75N-06.82E between the Board of Commissioners and Walter J. Stoebener and Ruth D. Stoebener, husband and wife, for purchase of 1.00 acre of right-of-way, 0.066 acre of temporary easement for construction, and 12 rods of woven fence, in the lump sum of \$575.88. This lump sum includes allowance for walnut trees as follows: one 17-inch diameter, one 14-inch diameter, one 12-inch diameter, three 10-inch diameter, and five 8-inch diameter. After review of the agreement it was moved by Mr. Neis that it be approved, seconded by Mr. Cragan, and carried unanimously.

Mr. Dooley then presented the Board an application from Continental Telephone of Kansas, Gardner, Kansas, seeking authority to construct buried telephone line at a point approximately 1050 feet north of the southwest corner of Section 17, Township 14S, Range 21E, in Douglas County, Kansas, and running northerly along county right-of-way through Douglas County and leaving said county on same county road approximately 1025 feet north of the northeast corner of Section 18, Township 14S, Range 21E, in Douglas County, Kansas. This application has been reviewed by the public works department and its approval is recommended to the Board by Mr. Dooley. After discussion it was moved by Mr. Neis that it be approved, seconded by Mr. Cragan, and carried unanimously.

Kanwaka Township
Accept roads in
Clinton Lake East.

Mr. Dooley then advised the Board that pursuant to Douglas County Resolution No. 78-26, dated August 17, 1978, Kanwaka Township Board has concurred in the recommendation of acceptance of the rock surfaced roads in the Clinton Lake Estates subdivision and further agrees to maintain these roads in accordance with accepted standards. With this information it was moved by Mr. Neis that the Board accept the recommendation of Mr. Dooley to place these rock surfaced roads, known as Lakeview Terrace, Lakeview Drive, 16th Street, and 16th Street Terrace in Clinton Lake Estates subdivision, in the Kanwaka Township Road Mileage with maintenance responsibilities for these roads assigned to the Kanwaka Township Board, seconded by Mr. Cragan, and carried unanimously.
