LeRoy McDermott, Douglas County Drug Abuse Council Coordinator, appeared before the Board to secure the Board's signature for a Health Education-Risk Reduction Grant Proposal for Funds to Deter Children and Adolescents from Smoking and Alcohol Use in the amount of \$19,059, with no local match required. This is to be submitted to the Center For Disease Control, Atlanta, Georgia. The Board discussed the hiring of an auctioneer to conduct an auction sale of surplus county property which is scheduled to be conducted on Saturday, July 26, 1980, at 1:00 p.m., at the County Shop Yard at 23rd and Santa Fe Tracks, Lawrence. This surplus property consists of office equipment, lumber and bridge planks, dump and pickup trucks, used tires, etc. The County will arrange for all necessary advertising. Mike Dooley, public works director, recommended that the Board accept the low quote of Charles E. Ledom, 1121 Kentucky St., Lawrence, as auctioneer for this surplus property auction for 3% of the total sales. After discussion it was moved by Mr. Neis that this recommendation be approved, seconded by Mr. Cragan, and carried unanimously.

Rezoning 21A to
B-3 - Brink

At the request of Garner Stoll, Director of the Lawrence-Douglas County Planning Department, the Board reviewed Item No. 9 of the minutes of the Lawrence-Douglas County Planning Commission dated July 27, 1977, and the minutes of the Board of County Commissioners dated August 17, 1977. This item was a request to rezone approximately 21 acres from A-1 (Suburban Home Residential) to B-3 (Limited Business). The area requested is generally described as being located on the west side of Clinton Reservoir Access Road "A", approximately 4000 feet south of Kanwaka Township Road 19. The request was submitted by William J. Brink. The planning commission forwarded this request to the county commission with the unanimous recommendation for its approval subject to two conditions:

1. That the property be platted; and,
2. That a development site plan be submitted to the planning commission for review prior to its submission to the Board of County Commissioners.

After further review and discussion it was moved by Mr. Cragan that the Board rescind Condition No. 2 of this planning item from the minutes of August 17, 1977, seconded by Mr. Neis, and carried unanimously.
