Lockwood Co., Inc. Reorder No. 185428-12-78

Personnel: Employ Kathy Hamilton, Valleyview Administrator, recommended hiring for Valleyview as follows:

*B. Ragan**P. Andersen**T. Kerr*

(1) Betty F. Ragan, in the position of certified nurse aide, permanent, full-time, at the rate of \$3.30 per hour, having begun work on August 18, 1980.

(2) Phyllis L. Andersen, to fill the position of dietary assistant, permanent, full-time, at the rate of \$3.10 per hour, having begun work on August 22, 1980.

(3) Terry E. Kerr, to fill the position of nurse aide, permanent, full-time, at the rate of \$3.10 per hour, having begun work on August 28, 1980.

After discussion it was moved by Mr. Cragan that these recommendations be approved, seconded by Mr. Neis, and carried.

*J. Harkins**Trans.*

Ms. Hamilton then recommended that Judith Harkins be changed from part-time registered nurse at a rate of \$6.05 per hour to acting director of nursing at a rate of \$7.00 per hour, effective August 16, 1980. After discussion it was moved by Mr. Cragan that this recommendation be approved, seconded by Mr. Neis, and carried.

*Misc.**Ch rec'd for old paper*

The Board noted receipt of check in the amount of \$143.30 from the Batliner Paper Stock Company in payment for accumulated computer paper and computer cards which had been stockpiled by the maintenance department. Check was remitted to the county treasurer for deposit to general fund.

*Sheriff - D. A. app.**Purch. pagers*

Sheriff Rex Johnson and District Attorney Mike Malone recommended the purchase of two Spirit pagers for each of their departments from Motorola, Inc., Overland Park, Kansas, at a total price of \$450 for each department. After discussion it was moved by Mr. Cragan that this recommendation be approved, seconded by Mr. Neis, and carried.

*Personnel: Term**S. Sutton*

Mike Dooley, public works director, notified the Board that Stephen T. Sutton will terminate on August 29, 1980.

*Pub. Works: app**Repair on dump truck*

Mr. Dooley appeared before the Board with two estimate of repairs for the repair of a 1976 two-ton Dodge Dump Truck which was damaged earlier this year. Mr. Dooley recommended that the Board accept the low estimate of Landmark Ford in the amount of \$398. After discussion it was moved by Mr. Cragan that this recommendation be approved, seconded by Mr. Neis, and carried.

Purch 3 file cabinets

Mr. Dooley then recommended that the Board approve a quote from M & M Office Supply for three legal size filing cabinets at \$259.20 each. Mr. Dooley stated that M & M Office Supply is the only place who can supply the filing cabinets to match the existing filing cabinets in the public works department. After discussion it was moved by Mr. Cragan that this recommendation be approved, seconded by Mr. Neis, and carried.

*Yankee Tank: app.**Statement from Black Veatch*

Mr. Dooley then presented the Board a statement for Black & Veatch, Kansas City, Missouri, consulting engineers, in connection with resident engineering services for the Yankee Tank Main Sewer District No. 2, for the month of July 1980, in the amount of \$3848.74. After review it was moved by Mr. Cragan that this statement be approved, seconded by Mr. Neis, and carried.

*Bridge - Co.: app.**Phase II on**Proj. 23 C-1166-01*

Mr. Dooley then presented an authorization to the Kansas State Historical Society to conduct a Phase II Field Reconnaissance Highway Archeological Salvage review on Project 23 C-1166-01 Formerly SOS 450(1). It is indicated that the cost of the Phase II Field Reconnaissance will not exceed \$100. After discussion it was moved by Mr. Cragan that this authorization be approved and that the Kansas State Historical Society be authorized to conduct the field reconnaissance in accordance with the terms of Secondary Roads Memorandum 75-1, seconded by Mr. Neis, and carried.

*Bridge Co.: app.**Appl. Un. Phone**30-14-19*

Mr. Dooley then presented the Board an application from United Telephone Company of Kansas, Inc., seeking authority to construct buried telephone cable along and across a county highway at a point approximately 875 feet west of the northeast corner of Section 30, Township 14S, Range 19E, in Douglas County, Kansas, and running east approximately 200 feet into the northwest corner of Section 29, through Douglas County. The application is to bury six pair, 22 ga. of telephone cable. This application has been thoroughly reviewed by the public works department and its approval is recommended to the Board by Mr. Dooley. After discussion it was moved by Mr. Cragan that it be approved, seconded by Mr. Neis, and carried.

*RWD #13**FAS 23-RS-1084(3)*

Mr. Dooley then presented the Board two utility agreements as follows:

(1) Between Rural Water District No. 3 and the Board of Commissioners of Douglas County for FAS 23-RS-1084(3) which agreement relates to provisions of K.S.A. 17-1901 as to the necessity for movement of utility equipment and facilities which are located on county right-of-way. The agreement indicates that relocation and/or necessary replacement of existing facilities which are currently located on private easement will be paid for by Douglas County as determined by company engineers, and that the construction or alterations of the company's facilities shall be completed within 90 days after the county furnishes to the company the required information.
