Independence, Inc.; Mary Louise Hancuff, representing the City of Baldwin and the Baldwin Senior Citizens Apartment Complex, and about seventy-five other interested citizens including a number of handicapped individuals were present. It was explained to all present that this was a grant application for four Jitney type vehicles (3 equipped with lifts) and proposed operating costs for one year. It was also explained the vehicles and related equipment are to be 80% federally funded and operating costs to be reimbursed at \$0.40 per ride. It was explained that it would be the intent of Douglas County to serve as sponsoring agency for the grant application and would lease the vehicles to Jitney, but with no county funds involved in the local matching dollars or in the present or future operation of these transportation services. Upon approval of Phase I the county in cooperation with other interested agencies will put together Phase II of the application that would be submitted at some future date. The audience present was assured by Ward Thompson, Jr., that he would not protest any future vehicles applied for by the Council on Aging either as replacement or expansion of vehicles. After a lengthy discussion in which Council on Aging voiced their support for the proposal and also their concern that no one restrict their transportation services to the elderly, it was moved by Mr. Neis that this grant application be approved and submitted to the Kansas Department of Transportation, seconded by Mrs. Bradley, and carried.

No further business, the Board adjourned to meet on Thursday, September 4, 1980.
