Mike Dooley, public works director, appeared before the Board with an authority to construct an overhead power line (7200 volt) from Kaw Valley Electric Cooperative Co., Inc. on Access Road A, Section 5, Township 13S, Range 19E. This was previously approved by the Corps of Engineers. After discussion it was moved by Mr. Cragan that this Agreement be approved, seconded by Mr. Neis, and carried unanimously.

Relocate Rt.
1273

Mr. Dooley then presented the Board with Resolution No. 80-44 which recommends the relocation of a portion of Federal Aid Secondary Route No. 1273 for the purpose of eliminating sharp turns, the center for said relocated road being described as:

Commencing at the Southeast corner of the Northeast Quarter (N.E. 4) of Section 1, Township 14 South, Range 17 East of the Sixth Principal Meridian in Douglas County, Kansas, thence N. 90° 00' 00" W. on the South line of said Northeast Quarter (N.E. 4) a distance of 1210.07 feet for a point of beginning, said point being the P.C. of a curve to the Northeast
