Mr. Dooley then recommended the submittal of an Application to the Division of Water Resources of the State Board of Agriculture to improve channel at site of Douglas County Bridge 12.75N-15.00E, to be accomplished under KDOT Project No. 23 C 1215-01 across Haskell Drainage Ditch at a location in the Northeast $\frac{1}{4}$ of Section 18, Township 13S, Range 20E, and the Northwest $\frac{1}{4}$ of Section 17, Township 13S, Range 20E. The purpose of this channel improvement is for protection of new bridge, approaches, and adjacent property, and improvement of flow through same. After discussion it was moved by Mr. Cragan that this Application be approved and forwarded, seconded by Mr. Neis, and carried.
