At the hour of 10:00 a.m., the Board discussed planning items with Garner Stoll, Director of the Lawrence-Douglas County Planning Department, and Linda Finger and David Guntert, planning department staff members. Wayne Kellum, zoning administrator, was also in attendance. The Board considered Item No. 14A and 14B from the Lawrence-Douglas County Planning Commission minutes of January 28, 1981. Item No. 14A is a Text Amendment--Amending the County Zoning Resolution by adding to it, Article 28, Flood Plain Management Regulations for the Unincorporated Portions of Douglas County. Item No. 14B is Text Amendments to the County Zoning Resolutions to the following sections: (Table of Contents), 4-1, 4-2, 4-5, 14-2, 18-2, 19-4, Article 28, 29-3.01 and 29-3.02. These items come to the Board with a recommendation of approval and adoption from the planning commission. After discussion it was moved by Mrs. Bradley that the Board concur in the recommendation of the planning commission, seconded by Mr. Neis, and carried.

The next item considered by the Board was Item No. 15 from the Lawrence-Douglas County Planning Commission meeting of January 28, 1981. This item is to amend the Subdivision Regulations to allow for the establishment of criteria and standards for the implementation of the County's Flood Plain Management Regulations. This item comes to the Board with a recommendation of approval and adoption from the planning commission. After discussion it was moved by Mrs. Bradley that the Board concur in the recommendation of the planning commission, seconded by Mr. Neis, and carried.

The next item considered by the Board was Item No. 16 from the Lawrence-Douglas County Planning Commission meeting of January 28, 1981. This item is a Text Amendment--Amending Article 19, Section 19-4, of the Zoning Regulations for the Unincorporated Territory of Douglas County, Kansas, adding the following farm implement repair use to the allowed conditional uses. The staff recommended approval of the amendment based upon the appropriateness and desirability of such services being conveniently located to farm usages. The planning commission also recommended approval. After discussion it was moved by Mrs. Bradley that the Board concur in the recommendation of the planning staff and planning commission, seconded by Mr. Neis, and carried.

Cable T.V. Tower

The next item considered by the Board was Item No. 17 from the Lawrence-Douglas County Planning Commission meeting of January 28, 1981. This item is a request for a Conditional Use Permit to allow for the erection and operation of a cable TV tower for TriCities Cable Vision, Inc. The property is generally described as being located approximately 4½ miles east of Baldwin on the southwest corner of Highway 56 and County Road 1061, requested by TriCities Cable Vision, Inc. This item comes to the Board with a recommendation for approval from both the planning staff and the planning commission, subject to the following condition:

- (1) That a shrub or cedar hedge be added to the front (north) side of the property and any parking area be shown as gravelled or paved.
