Order# 6 Agree Finney Tumpseed	 Mr. Dooley then presented the Board Supplemental Agreement, Change Order No. 6 to the Agreement dated November 27, 1974, between the Board of Douglas County Commissioners and Finney & Turnipseed, consulting engineers, Topeka, Kansas, relative to field surveys, design, plans, specifications and construction engineering services for bridges over the Kansas River in the vicinity of Massachusetts and Vermont Streets in the City of Lawrence, Kansas, and for bridges and approach grading for specified bridges in Douglas County. This Supplemental Agreement changes the following:

	After discussion it was moved by Mr. Cragan that this Supplemental Agreement, Change Order No. 6, be approved, seconded by Mrs. Bradley, and carried unani- mously.	
Bridge-Co.:a 12/W. 51-1 Hamlin	Mr. Dooley then presented the Board a contract for right-of-way for Project No. 81-1, Bridge No. 1.50N-14.52E, between the Board of Commissioners of Douglas County and Richard E. Hamlin and Luceil F. Hamlin, husband and wife, Baldwin, Kansas, for 1.146 acres of right-of-way easement, 0.0996 acres of temporary easement for construction, and 32 rods of fence, in the lump sum of \$695.39. After review of this contract it was moved by Mrs. Bradley that it be approved, seconded by Mr. Cragan, and carried unanimously.	

Wiscuss Bond Mr. Dooley then discussed the Bond Bridge Program with the Board. In order to maximize the use of the available bond money which remains to be used on the lge rogram fifty rural bridges, it is recommended that a total of \$80,314.45 be reimbursed to the Birdge Construction 1975 Fund from the Special Bridge Fund. This would allow the construction of seven (5 remaining plus 2 reimbursed) additional bridges under the bond program. Further leverage in this program can be attained by taking advantage of federal funds and Special Bridge Funds to replace 12.75-15.00 (Haskell Avenue). The following is a recommended bridge replacement program to complete the fifty rural bridge program taking advantage of federal and Special Bridge Funds to build as many structures as possible. After reimbursing the Bond fund \$80,314.45, the total obligated amount on fifty rural bridges is \$4,587,009.71, or a total amount remaining of \$1,287,990.29.

If additional monies are required to finish this program above \$5.85 million, it is further recommended that the necessary funds be drawn from the Special Bridge Fund. A breakdown is as follows:
