The Board considered Resolution No. 81-13 which resolution asks for a speedy appeal of a court ruling against landowners opposing a landfill in southern Jefferson County. The Board of County Commissioners of Douglas and the City of Lawrence are currently expending substantial sums of money which conceivably could exceed the sum of \$100,000 in order to place said sanitary landfill in operation by April 1, 1981. The Board of County Commissioners requests that all proper and legal steps be taken by all parties to said appeal to expedite said appeal to obtain a final resolution of said action in the shortest possible time. After discussion it was moved by Mr. Cragan that Resolution No. 81-13 be approved, seconded by Mr. Neis, and carried.
