

The development permit must include certification from a registered professional engineer, architect or land surveyor (licensed to do business in the State of Kansas) that the lowest floor, including basement, is a minimum of one (1) foot above the regulatory flood plain elevation. The building permit is null and void after said sixty (60) day period if such certification is not provided. Occupancy of the structure shall be illegal prior to the approval of a development permit.

3. Amend ARTICLE 28, SECTION 28-5.2c. to read as follows:

- c. A registered professional engineer, architect or licensed land surveyor shall certify that the elevation of a proposed structure or substantial improvement is above the regulatory flood elevation.

4. Amend ARTICLE 28, SECTION 28-7.3f. to read as follows:

- f. Certification of the elevation floodproofed by a registered architect, engineer or licensed land surveyor;

After discussion it was moved by Mr. Cragan that this resolution be approved and published in accordance with the requirements of the law, seconded by Mrs. Bradley, and carried unanimously.

Ted McFarlane, Douglas County ambulance service manager, appeared before the Board to discuss the proposed ambulance station relocation. Mr. McFarlane recommended that the county should retain the current station at 1839 Massachusetts and renovate it if an architect says it's feasible. The Board agreed to set up a meeting with officials from Lawrence Memorial Hospital to discuss the possibility of housing an ambulance at the hospital. Mr. McFarlane stated that since 82 percent of the emergency calls are within the city limits, a new station in the south part of the city wouldn't improve service enough to justify abandoning the present station.

No further business, the Board adjourned to meet on Monday, April 20, 1981.
